emerging markets. The EMP assists US entities in developing, maintaining, or expanding exports of US agricultural commodities and products by funding activities that enhance emerging markets' food and rural business systems, including reducing trade barriers. The EMP is intended primarily to support export market development efforts of the private sector, but EMP resources may also be used to assist public organizations. The EMP is administered by personnel of the Foreign Agricultural Service on behalf of the Commodity Credit Corporation.

Quality Samples Program (QSP)—Global Programs

The QSP is designed to encourage the development and expansion of export markets for US agricultural commodities by assisting US entities in providing commodity samples to potential foreign importers to promote a better understanding and appreciation for the high quality of US agricultural commodities. The QSP is administered by personnel of the Foreign Agricultural Service on behalf of the Commodity Credit Corporation.

Foreign Market Development (FMD) Cooperator Program—Global Programs

The Cooperator program is designed to maintain and develop foreign markets for US agricultural commodities and products through cost—share assistance. Financial assistance under the Cooperator program will be made available on a competitive basis and applications will be reviewed against the evaluation criteria contained herein and in the Cooperator program regulations. All US agricultural commodities, except tobacco, are eligible for consideration.

Market Access Program (MAP)—Global Programs

The MAP is designed to encourage the development, maintenance, or expansion of commercial export markets for US agricultural commodities and products through cost—share assistance. Assistance may be provided for either for generic or for brand promotion activities. While activities generally take place overseas, reimbursable activities may also take place in the US. Under the MAP, Foreign Agricultural Service enters into agreements with eligible participants to share the cost of certain marketing and promotion activities

USAID Advancing Food Fortification Opportunities to Reinforce Diets (USAID AFFORD)
